Frequently asked questions (FAQ): MitID

What is MitID?

MitID is the Denmark/Greenland's digital ID. You use it to proof who you are when you access online. You use the same log on whether you log on to your online bank **MitID** is primarily an app.



Where do I get MitID?

You can get MitID at a Citizen Service Centre in Commune.

To get help from your Citizen Service Centre you must:

- 1. Bring valid documentation (the documentation must be brought in physical form for example: driving license)
- 2. Answer a number of questions about yourself (based on data from the CPR Register) or bring a witnesser, who can confirm who you are.

What is a witnesser?

A witnesser is a person, who will visit the citizen service centre with you and confirm who you are. To be a witnesser, the person must be 18 years or older and have had MitID for more than 30 days. **The witnesser must bring valid documentation with picture (see below) and his or her MitID**. The person is allowed to be a witnesser 3 times within a 120 day period.

Foreigner or living outside Greenland?

Are you a foreigner or living abroad, it is recommended that you bring a witnesser, as there might not be enough information about you in the CPR Register.

Frequently asked questions (FAQ): NemKonto

What is NemKonto?

A NemKonto is a normal bank account which you already have, and you assign it as your NemKonto. All payments from public institutions will be transferred directly to this account.

Who needs to have NemKonto?

All citizens and companies in Denmark and Greenland

How do I inform the authorities about my NemKonto?

Contact your bank and inform them which account to assign as your NemKonto

Visit www.nemkonto.dk and assign an account number yourself. You can only do this if you have a NemID or a digital signature.

Change your NemKonto in your home banking system.

Can I still receive my money by check?

In principle, the money can no longer be paid by check once NemKonto takes effect. However, there might be special cases where a public entity is unable to make payments electronically. In such cases, it's up to the particular public office to find a solution.

What does it cost to set up a NemKonto?

It is free of charge for both citizens and companies to assign an account as a NemKonto.

Frequently asked questions (FAQ): e-Boks

What is eBoks?

e-Boks is a trusted Nordic provider of secure platforms and digital postboxes that enables efficient communication between public authorities, citizens and businesses.

For example, in case You expect to receive excess tax from the Greenlandic Tax Agency, an e-mail will automatically be forwarded to Your private eBoks, an thereafter automatically deposited onto Your NemKonto. Therefore, if You do not have a NemKonto just yet, please make sure to apply for one, otherwise the public authorities will not be able to pay out what they owe You, for example in regards to excess taxes. eBoks is an App:
